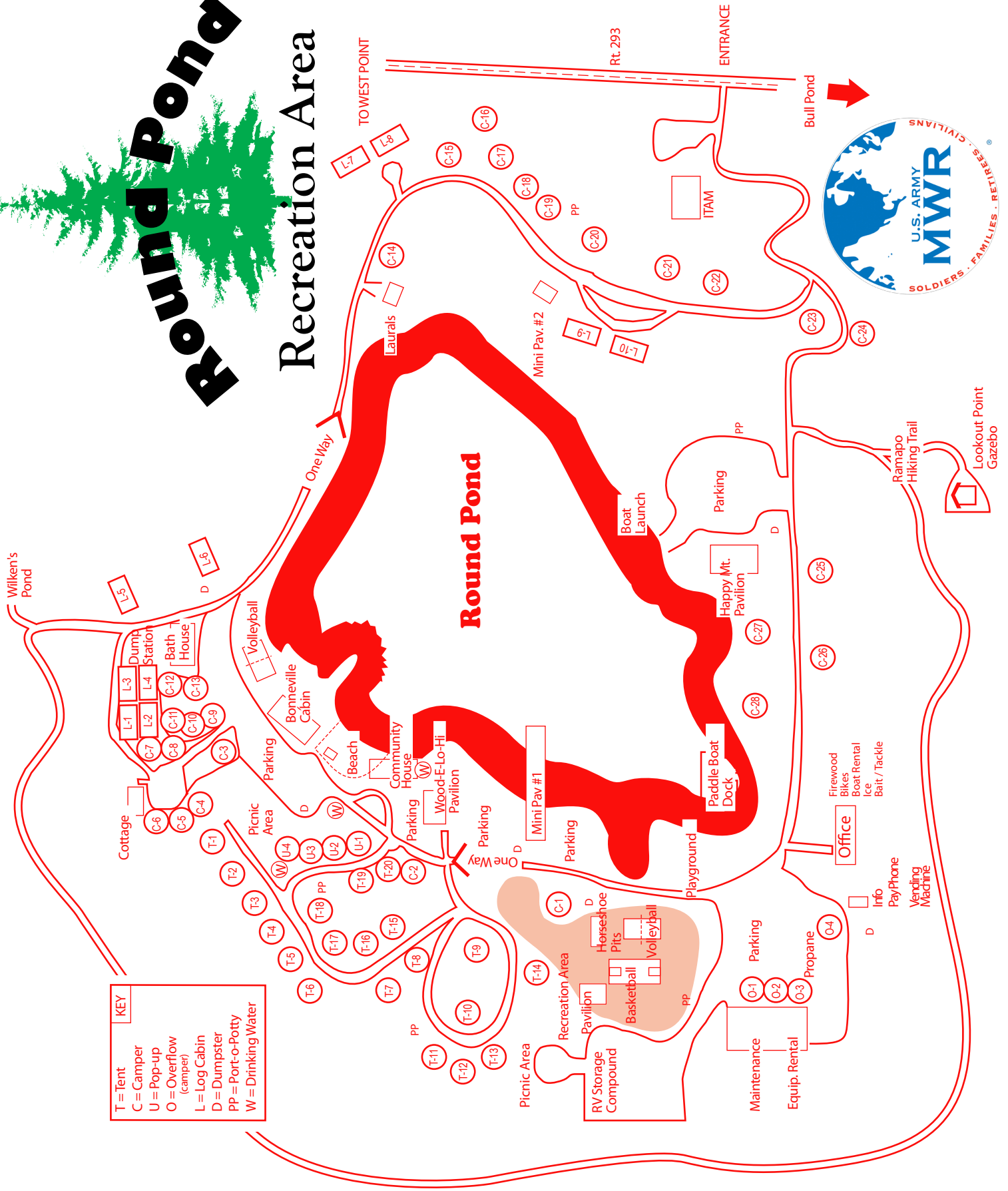


# Round Pond

## **CAMPER POLICIES AND INFORMATION ROUND POND RECREATION AREA**

1. The Round Pond office is open 7 days a week from the hours of 0800-1800. Check-in time is between 1 pm and 6 pm and check-out is at 11 am. All campers arriving after 6 pm must check in with the Caretaker. There is a \$25 deposit for all cabin rentals.
2. Camp sites are limited to no more than 2 tents or 1 camper, 2 vehicles and 6 people per site.
3. Camper and tent sites are strictly for recreational residency and are not party facilities. Parties may be booked at the pavilions only.
4. The person booking a site is 100% responsible for their guests and must remain with them at all times.
5. Campsites are not to be altered, expanded or amenities shared/taken from other campsites.
6. Fire in grills provided must be made with charcoal only. Fires in ground pits or fire rings may be made with wood. Open ground fires (no containment system) are not permitted at any time. All fires must be extinguished before you leave your site.
7. Cutting of trees, branches or saplings is prohibited. Firewood is available for purchase in the office. Outside firewood brought in beyond a 50 mile radius is prohibited.
8. Dumping of any camper waste water, including gray water, other than at the dump station behind the bath house is prohibited. We offer a honey wagon service for \$8 a pump out on Mondays and Fridays by appointment.
9. Firearms, bows and arrows, ATV's and motored scooters are not permitted at the campground.
10. Pets are not permitted in the playground, beach, picnic areas, cabins or in the water at Round Pond. Pets should be leashed and cleaned up after at all times. Management reserves the right to ask patrons with loud, unruly pets to remove them from the campground.
11. Alcoholic beverages may be consumed in moderation IAW laws established by the state of New York.
12. Quiet time begins at 10pm. At this time please keep noise to a minimum and do not have bright lights shining. Campers are asked to respect other campers by not using vulgar language or trespassing on other sites. Management reserves the right to ask unruly campers to leave the premises.
13. Swimming at Round Pond is allowed in the beach area only during posted hours.
14. Persons age 16 and older must have a current NYS fishing license as well as a West Point permit in order to fish at any of the installation ponds. (Both are available for purchase at the Round Pond office).
15. Campers are required to check out at the office upon departure and ensure their sites are clean and trash is taken to dumpster.
16. Washing of vehicles at the campground is prohibited.
17. Keep in mind there is limited parking at Round Pond for parties.
18. Children under the age of 14 must be supervised at all times.
19. The speed limit throughout the campground is 10 mph and the road is one-way.
20. Paddleboats are available for rent from 8am to 5:30pm. There must be a person over 16 years of age on the boat and everyone must wear life vests.
21. Those patrons fishing should always dispose of their trash and not leave fishing line, bait containers or garbage on the shoreline or in the boats.
