Dear Parents:

I am writing to notify you that on 1 December, the Army will implement the School Year (SY) 2022-2023 Army Child and Youth Fee Policy as required by the SY 2022-2023 Department of Defense (DoD) Child Development Program Fee Policy. The DoD Fee Policy, issued each year, prescribes uniform fee regulations for military child developments programs based on Total Family Income (TFI). The key points included in the SY 2022-2023 Child and Youth Fee Policy are:

1. The fee policy increases the number of family income categories from 13 to 14 and increases the highest total family income category to \$154,051 and above. TFI ranges have been adjusted and families may see a decrease or increase in their category.

DoD Contractors and Specified Space Available Patrons are not eligible for the MCR.

LATE PICK-UP FEES: Family fee of \$1.00 per minute for first 15 minutes; then \$8.00 for next 45 mins. per child/site. If Family has children at different sites, late pick-up fees are assessed per site. Fee is payable before the child is readmitted to care.

For services billed twice a month (1st and 15th), a one-time \$10.00 per child late payment fee will be assessed on the 6th business day of each missed payment cycle.
