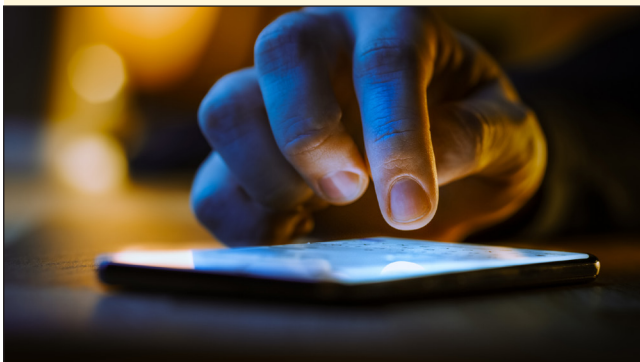

Family Advocacy Program (FAP)



The U.S. Army Family Advocacy Program (FAP)

Dedicated to the prevention, education, prompt reporting and intervention of domestic violence and child abuse, the FAP helps Soldiers and Families recognize and meet unique challenges of military lifestyles. It is also designed to address domestic abuse, child abuse, neglect, and problematic sexual behavior in youth. Our focus is on prevention, education, prompt reporting, investigation, intervention and treatment.

There are additional programs within the Family Advocacy Program that help with specific needs.

Military and Family Life Counselors (MFLCs)

A key outreach service to Soldiers and Families. Enhanced community Family support services by offering licensed clinical social workers and psychologists to address various issues that Soldiers and Families face before and after deployment.

Victim Advocacy Program (VAP)

Victims of domestic violence and sexual assault have around-the-clock access to services, including emergency assistance, information, referrals, and ongoing support in accessing medical, behavioral health, legal, and law enforcement services on and off garrisons.

Transitional Compensation (TC) Program for Abused Dependents

Under a congressionally mandated program, abused dependents of military personnel may be eligible for one to three years of benefits and entitlements, including temporary financial compensation, medical care, and commissary and exchange privileges.



Domestic Violence Reporting Options

Restricted Reporting: Domestic abuse victims may choose to make a restricted report which provides access to the full range of FAP services, including medical care, counseling, and support from a victim advocate to develop a safety plan. With a restricted report, military law enforcement and command will not be notified. Restricted reporting is not available to children.

Unrestricted Reporting: Victims may choose to make an unrestricted report of domestic abuse. Both command and law enforcement are notified and become involved. Victims have access to support and protection from command, such as a No Contact Order or a Military Protective Order. Victims have access to the full range of FAP services, including medical care, counseling, and support from a victim advocate to develop a safety plan. With an unrestricted report, victims may also seek legal services through the military, and work with a victim advocate to apply for transitional compensation, if applicable.

Community-Based Educational Opportunities

FAP provides a variety of community-based educational opportunities for Soldiers and their families. Our services include seminars, workshops, counseling, and intervention to help strengthen Army Families, enhance resiliency and relationship skills, and improve quality of life.
